Chair opened floor to questions regarding topic of election results only-

- Road Work committee – Assigning a new committee. In trying to find information about the prior roadwork committees I cannot find what they did and were officially tasked with. HRS 414d-148 is required to be followed. Since they are a direct committee of the board, who on the board was a chairman and responsible. Since these meetings were not open to the membership, then they would have been in direct violation of HRS 414d. I cannot find any meeting notes that are required for either the road work committees or the gate committee. And per HRS414d-149 there are general standards required for these.

*Point of Information:* by member Packy Taylor purchased and spent \$8500 for a paint sprayer and \$8000 for the driver. In the storage container we had over 70 gals of white paint that had been there since 2018 and probably one quarter of that was bad but we still used it to paint the white lines on the roads. Purchased \$1200 yellow paint. So where did this misinformation during the last meeting that we spent 30k on painting our roads? Who told him that misinformation in the first place?

- Status of oil truck and chipsealing – we currently have 1000 gals of mixed fogseal on sight
- Board members:

*Chair made a Motion* for Leonard Hudson to come onto our board for 2023. This will be a one-year term and must be voted in by membership to continue on after. Mats second motion, ALL IN FAVOR PASSED.

Voting procedures/counting ballots

- 2023 quarterly meetings. The board decided to go to quarterly meetings on Saturday at noon. Per our bylaws 3.7 Board Meetings. The Board shall meet monthly, or quarterly, and any such meetings shall be held on such date, time and place in the community as shall be specified by the Board. I was asked to place this on the agenda but cannot find anything that legally says we cannot go to quarterly meeting. Also what legally says we have to vote on this? The board agreed but misinformation is rampant that we must vote on this. Show me a legal reference.
- Maikai Blvd dead end - We spent close to \$6500 on the end of Maiki using our own equipment and labor as well as volunteer labor that was not part of this cost. The estimate to pay a contractor would have been over \$15,000 (thru 3 bids and sealmaster). My question to the prior road work committees is why has that road not been repaired prior to now as it is by far the worst road in the subdivision. It has been on several agendas from board meetings in the past and should have been repaired 20 years ago as now it will be to be completely redone. WHY? We have 52 miles of road and for several years now road work committees have felt we only need to work on 1 mile a year. Chipseal only has a shelf life of max 12 years. The boards that created road maintenance had 3 to 5 miles a year on their budget so why did we go to 1 mile and not keep up with the cost of doing business? What did the prior road work committees do? What education in road work did these committees have. Sealmaster was here a couple months ago and read most of our roads and I showed them Kyle Puas work and Les Iversons work. The said that both products failed miserably. Lev Iverson added water to a product that chemically cannot take on water as it is engineered to be water free. Kyle added way too much water to his product and the first rain storm washed it all away. WHY? What road work committee approved that expenditure???
